**NO Emergency Medical Authorization**

School personnel will authorize an emergency room doctor to treat my child and call another doctor for consultation and treatment in the event special treatment is necessary, such as surgery, orthopedics etc. School personnel will hold this authorization as long as student named is enrolled in this school district.

**NO Technology Acceptable Use Policy**

As the student’s parents or legal guardians, we agree to read and uphold the school technology use policy and discuss it with our son or daughter.
